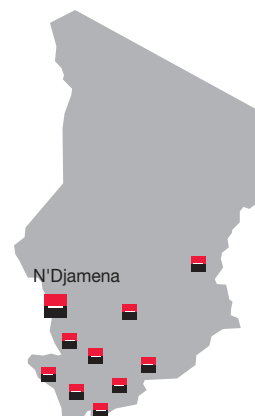

The National Investment Charter of the Republic of Chad is a legal framework that aims to create a climate conducive to investment and business creation.

It is a reflection of the country's commitment to improving the institutional, tax and financial ramifications of the private sector in order to foster growth and diversify the country's economy through a clearer definition of the role of the State and the harmonious development of the private sector.
